



## Corporate Seasons Pass Frequently Asked Questions

**Q: Who can purchase a corporate pass and how much does it cost?**

- A. Full time employees and their spouse or domestic partner. No other family members are eligible (children, siblings or parents). The price is \$699+ tax, with 10-14 participants and \$659+ tax with 15 or more participants. (\$740.94 & \$698.54 w/taxes)

**Q: Who do I call with questions?**

- A. The coordinator at your company should be able to ask any questions. They will be the liaison to Sugarbush Resort. If they do not have the answer, they will call Sugarbush to get the answer for you.

**Q: I have kids under 12, what is the best deal for me?**

- A. It depends on the size of your family and ages of the children. Please use the current pricing provided to calculate the best option for your family. Keep in mind that with all corporate passes there is no "kids ski free" option as there is with our retail passes. As an example, here is how it would work out for a family of four with two kids under the age of 12:

**Corporate Pass: \$2329.76 including tax)**

Retail All Mountain: \$2,541.88

Mount Ellen Plus: \$1693.88

Mount Ellen Only: \$1163.88

**Q: What qualifies as a domestic partner?**

- A. A couple that is not married and has shared personal finances for at least a year.

**Q. Will I need to prove my Domestic partnership?**

- A. Yes, you may be asked to provide proof of fiscal partnership. For example: co- signed lease, joint checking account, shared medical insurance, wedding venue contracts etc. We understand that more couples this day in age are waiting to get married and it is more common to live with a significant other before marriage, or to never get married at all. We would like to extend the discounted pass to these couples as well as married couples.

**Q. Do the prices include sale tax?**

- A. No, they do not. Please add 6% sales tax to the amount of the check or on the pass form.

**Q. Whose address to I put on the pass form?**

- A. Please put your personal address and phone number so that we can contact you directly if there are any issues that we need to clarify.

**Q. What do I need to give the coordinator at my company?**

- A. Pass form completely filled out, payment (including tax), proof of employment (recent pay stub), and proof of domestic partnership if applicable.

**Q. What do I need to purchase a pass?**

- A. Fill out the pass form with all passes purchased, payment (cash/ check- credit card acceptance pending), and proof of employment. We prefer a current pay stub as proof of employment, but may accept other forms such as a photocopy of your company ID, a pay stub with the dollar amounts blacked out, etc. Pass in all paperwork to the company's coordinator to be submitted to Sugarbush Resort.

**Q. Is there a discount for children?**

- A. No, children need to purchase a full priced seasons pass. You can purchase this on the same order form with your corporate pass.

**Q. Are there Blackout dates?**

A. No, the Corporate Pass is an All Mountain pass, no black out dates and is valid at both mountains.
