

**Chittenden Central Supervisory Union
Staff and Student-Parent Electronic Information Resource Agreement**

Please read this document carefully. When signed by you (and your parent/guardian if you are a student under the age of 18), it becomes an agreement between you and the District. Your signature indicates that you agree to abide by the conditions and guidelines established herein.

Terms and Conditions of This Agreement

These policies shall apply to:

1. Users of electronic information resources which are utilized with equipment located or accessed in the District.
2. Users who obtain their access privileges through association with the District.

Personal Responsibility

I will accept responsibility in reporting any misuse of the network to the System Administrator. Misuse can come in many forms, but it is commonly viewed as any material sent or received that indicates or suggests pornography, unethical or illegal behavior, racism, sexist, inappropriate language, or violation or other issues as described below.

Acceptable Use Guidelines

- I agree the use of electronic information resources must be in support of education, research and the educational goals and objectives of the District.
- I agree not to submit, publish, display, or retrieve any defamatory, abusive, obscene, profane, sexually oriented, threatening, racially offensive, harassing, or illegal material other than for educational purposes as approved by a District educator.
- I will abide by all copyright regulations.
- I will protect my own and others' personal information. I will not reveal personal addresses or phone numbers of those of students or colleagues.
- I understand electronic mail is not private.
- I will not use the network in any way that would disrupt the use of the network by others.
- I understand many services and products are available for a fee and acknowledge that I am responsible for any expenses incurred (such as on-line buying, research fees, etc.).
- I will not use the network for commercial purposes.
- I will follow all of the rules of the District's Discipline and Required Student Behavior policy while using electronic information resources.
- I will not attempt to harm, modify, or destroy hardware or software, or interfere with system security.
- I agree to remove my unwanted and unused files regularly.

Privileges

I understand the use of electronic information resources is a privilege, not a right, and may be revoked at any time.

Consequences

I understand infractions of the provisions set forth in this Agreement may result in the suspension or termination of access privileges and/or appropriate disciplinary action.

I understand activities in violation of state and federal statutes will be subject to prosecution by those authorities. I understand disciplinary action may be taken by the District as appropriate.

I understand the administration, faculty, and staff of the District may request the System Administrator to deny specific user accounts due to inappropriate use.
